

CIRCA RESORT & CASINO GIVEAWAY (THE “GIVEAWAY”)

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED BY THE END OF EACH ENTRY PERIOD. VOID WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT. TRAVEL NOT INCLUDED.

ELIGIBILITY: The Giveaway is open only to legal residents of the fifty (50) United States (excluding New York and Florida) and the District of Columbia (the “**Eligible Territory**”) who are twenty-one (21) years of age or older at the time of entry. The Giveaway is subject to all applicable laws, rules, and regulations. Void outside the Eligible Territory and where prohibited or restricted by law, rule, or regulation.

HOW TO ENTER: The Giveaway period begins at 12:00 AM Pacific Time (“**PT**”) on March 25, 2026 and ends at 11:59 PM PT on September 27, 2026 (the “Giveaway Period”) and will be divided into a maximum of eighty-one (81) entry periods (hereafter, each an “Entry Period”). The first Entry Period will begin at 12:00 AM PT on March 25, 2026 and end at 11:59 PM PT on the date of the first A’s home game win of the 2026 regular season (each, a “**Home Game Win**”). Each subsequent Entry Period will begin at 12:00 am PT on the day following each Home Game Win and end at 11:59 pm PT on the date of the next Home Game Win. The last Entry Period will end at 11:59 PT on September 27, 2026. Online entry only. No other method of entry will be accepted. Limit one (1) entry per person/email address for the entirety of Giveaway Period. Additional entries beyond the specified limit will be void. Non-winning entries to any Entry Period **will** roll over and will be included in subsequent Entry Periods, if any. The amount of Entry Periods will depend on the number of Home Game Wins (up to a maximum of 81 Entry Periods). The Athletics will be the official timekeeper for determining the date and time of each Home Game Win.

By successfully transmitting a completed entry form during the Entry Period as directed, you will be entered in the Giveaway. RANDOM DRAWING; ODDS: The following business day after a Home Game Win (“**Drawing Date**”), one (1) potential winner will be selected by random drawing from among all eligible entries received by the end of the applicable Entry Period. Subject to verification of eligibility and compliance with these

Official Rules, each potential winner of an Entry Period will be declared the official winner of that Entry Period.
